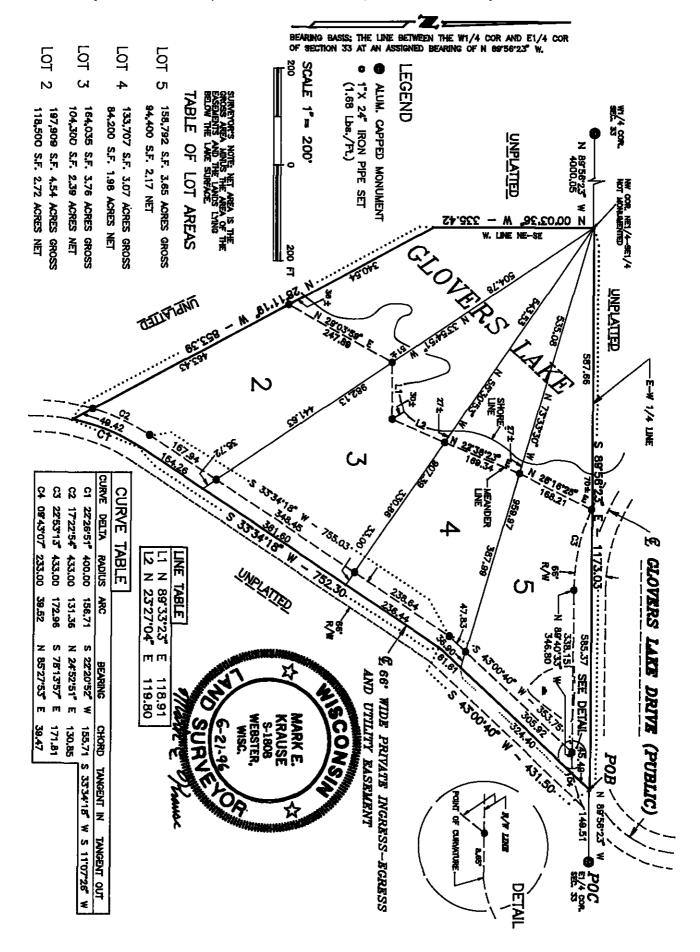

SURVEYOR'S CERTIFICATE

THAT the exterior boundary of the land parcel surveyed and mapped is described as follows:

A parcel of land located in the Northeast Quarter of the Southeast Quarter of Section 33, Township 35 North, Range 15 West, Town of Johnstown, County of Polk, State of Wisconsin and more particularly described as follows:

THENCE 156.71 feet along the arc of a circle concave to the Southeast whose radius is 400.00 feet the chord of said arc bearing S22°20'52"W 155.71 feet along the aforementioned easement:

THENCE N28°11'19"W 853.39 feet to a point on the West Line of the Northeast Quarter of the Southeast Quarter, Section 33;

THENCE NOO°03'36"W 335.42 feet to the Northwest Corner of the Northeast Quarter of the Southeast Quarter, Section 33;

THENCE S89°56'23"E 1173.03 feet along the East-West Quarter Line of Section 33 to the Point of Beginning.

This parcel contains 654,446.78 square feet 15.02 acres gross (401,400 square feet 9.21 acres net) and is subject to easements and restrictions of record.
